The Total Registration Payment will include: 1. TACKLE REGISTRATION FEE: The Registration fee for each Football Player is \$250.00 this includes \$50.00 refundable volunteer deposit upon completion of volunteer time. 2. TACKLE EQUIPMENT DEPOSIT: The equipment deposit for each Football Player is \$150.00.

FLAG REGISTRATION FEE: The Registration fee for each Football Player is \$110.00 this includes \$25.00 refundable volunteer deposit upon completion of volunteer time.

TACKLE VOLUNTEER TIME: Two volunteer times per season for each Football Player. Normal hours for volunteer is 1 ½ to 2 hours per volunteer time with a total of 4 hours per tackle season.

FLAG VOLUNTEER TIME: One volunteer time per season for each Football Player. Normal hours for volunteer in 1 ½ to 2 hours per volunteer time with a total of 2 hours per flag season.
